The 2023 AGM Minutes were on line with the Financial Statement provided to all who attended the AGM. Motion to accept minutes by Rod Adamthwaite, 2nd by Kevin Barker. Nobody opposed – Motion Carried.

No Business arose from previous Minutes

New Business

By-Laws and Constitutions were updated to align with the Operating model for the association and to provide greater transparency with the membership. A few notable additions are below.

- Clarified financial support for teams that qualify for league final tournaments
- Corrected verbiage related to pronouns and age categories
- Added information on player movement considerations

- Added verbiage related to Staff positions
- Added verbiage that sets the foundation for fundraising at the association and team level

Approved in previous Executive meetings and requires 2/3 vote of members in attendance at this AGM

Additional changes may be required to align with provincial regulations – ONCA. If required, a special meeting could be called to be approved.

NEW – team level fundraising policy will be communicated prior to start of next season

Largest registration ever, AGAIN, with over 470 players registered with LMH

- Approx 320 in boys & 150 in girls
- Increase of approx. 70 players from previous high; increase of almost 150 players in 3 years

- OWHA Provincial Qualifiers U11B, U13C, U15B, U18B
- WOGHL Day of Champions U11HL & U13HL were finalists
- International Silver Stick U13A & U18B were finalists

- U11 Rep Shamrock Tier 2 Champions
- U15 LL LMLL Tier 4 Champions
- U21 undefeated season & OMHA Champions
- Many other tournament victories throughout the season

LMH Organization record: 357 wins - 384 losses - 146 ties = 887 games

- 2022/23 - 720 games

LMH Sponsorship Program (raised approx. \$10k)

 - draft night was a huge success; players and families had a blast

Continued with Player and Goalie Development sessions

- Katrina Jeromkin (power skating), Jason Van Spronsen (goalie clinics), BK Hockey (player skills clinics)

Secured extra ice in Huron Park and different hours in Lucan that teams were able to take advantage of throughout the season

- U9-U21 all teams offered additional full-ice practices
- \$275k spent for ice time in Lucan/Huron Park/Parkhill/Komoka more games, more practices

LMHA Junior Coach Program was a huge success

Nicholas Smith Memorial Award recipient for third consecutive season

Increased partnership and presence with Lucan Irish Junior Six team

- Flag bearers at every home game; more ideas for next season

Looking Ahead 2024/2025 Season

Anticipate increased registration numbers; as community grows, so does our membership

- Introducing registration limits for U9-U18; last season tipped the scales of our limits and decision had to be made to ensure we can maintain or improve on the 2023/24 season experience
- Strong chance we will host a U21 Boys team again next season; combine with Ilderton to make that happen

Girls - Spring Tryouts for U11-U18 teams

Boys – second entry teams to be determined based on registration numbers and depth of skill

Registration is live and will close at the end of May

Additional ice times to be offered in Huron Park, perhaps elsewhere; doing everything we can to provide more full-ice practices to teams playing full-ice hockey during the season NEW team level sponsorship policy; revamped organization level sponsorship

- More details will be shared in the coming weeks

Return of Development Ice opportunities including checking clinics, power skating, players skills and goalie clinics

Plan to host tournaments again – Ken Bailey, jamborees
