- Head Coach applications up and due mid-Feb
- Coach feedback is closing on Jan 31
- AV Coaching application up to Feb 28

### **OMHA** - Ben

- Roster Deadline is Feb 10, after that date Rosters will be locked; U11-U21 benches/player rosters were completed in November (with a few late additions)
- U7 Pathways: Due to complaints to OMHA at other centres, a reminder was sent to enforce U7 to play cross ice as per the Hockey Canada pathways. A complaint was raised to OMHA by LMH members which has caused Lucan to be imposed the strict operating model for U7 games. A reminder that all engagement with OMHA is through the reps and/or president
- Player movement: OMHA/OHF has opened the movement off players at all levels (AAA-LL/HL), to any association that a player wants to tryout, play.
  - \*(Associations can set restrictions, similar to what London Jr Knights have implemented).
  - \*Tampering: OMHA/OHF have set specifications on rules on centres recruitment of players after the player movement changes.
- Bench quals/Team Officials quals for 2025-26 have been posted
- Fee schedule, Season Calendar 2025-26 are released by OMHA which explains dates for spring/fall development ice, evaluations, tournament starts etc. as well as cost per team registration for upcoming season.

- A few teams continue to decline extra practice ice

- Rafflebox 50/50 was almost ready to launch but Skating launched two weeks ago; Decision not to overlap their programming
- Looking into a potential "Hockey Day in Lucan"

### Shamrock - Rod

- U11-U18 to Feb 7<sup>th</sup>, Playoffs start Feb 8<sup>th</sup>
- U21 to Feb 14<sup>th</sup>, Playoffs Feb 15<sup>th</sup>
- Adding in final playoff series with top 2
- U9MD Champ by Brydges in Komoka early April
- U11-U15 All Star game in Dresden at the end of the season

### **Lambton Middlesex Local League - Hugh**
